McIntosh Town Council Meeting Civic Center 5835 Avenue G April 9, 2020

The meeting was called to order with the reciting of the Pledge to the Flag via conference call.

Roll call was taken with Council President Mullikin, Vice President Callahan, Council Member Ciotti, Council Member Roddy, Council Member Dodd, Mayor Hamilton, Attorney Sarah Wolking and Town Manager Nelson present.

Council Member Callahan made a motion to accept the consent agenda. Council Member Roddy seconded the motion. **Motion passed and carried 5-0.**

<u>Guests:</u> Richard Powell, with Powell and Jones CPA, presented the 2019 Financial Report. Powell noted that the town was in sound financial condition and had no findings. He noted that the town had a end of year balance of \$1,876,925. He stated that 72% of the town's assets had depreciated and that it was fiscally sound to have a large reserve when this is the case to cover infrastructure needs.

Deputy Preston Bowlin, head of Marion County Emergency Management, gave a COVID-19 overview.
