Part I – Charter

Article III – Legislative Branch

Sec. 3.04 - Mayor; president; vice-president

(1) Election. The Town Council shall hold an organizational meeting no later than on the second Tuesday in November and elect from its Members (or the Mayor) a President and Vice President who shall serve at the pleasure of the Town Council for a term of one year. In the event a majority of the Town Council is unable to agree upon the President and/or Vice President within seven (7) days after the organizational meeting, then such President and Vice President shall be the Town Council member(s) receiving the largest number of votes in their most recent election. For purposes of this Section a Town Council member who was elected unopposed shall be deemed to have received the highest number of votes.

(2) Duties. The President shall preside at meetings of the Town Council. In the absence of the President, the Vice-President shall preside at meetings of the Town Council.

IV. **ELECTION OF PRESIDENT**

Cllr Ciotti pointed out the criteria (referenced above) of the election of both President and Vice President.

Cllr Naworensky nominated Melinda Jones
Vice President Ciotti nominated Eva Jo Callahan

Nominations were closed. President Callahan called the vote by raising their hand.

Melinda Jones received two votes
Eva Jo Callhan received three votes

Current President Eva Jo received the majority number of votes to serve as President.

V. **ELECTION OF VICE PRESIDENT**

Cllr Sindledecker nominated Ciotti
Cllr Naworensky nominated Melinda Jones

Nominations were closed. President Callahan called the vote by raising their hand.

Ciotti received three votes
Jones received two votes

Current Vice President Ciotti received the majority number of votes to serve as Vice President.

VI. **CITIZEN COMMENTS**

Melinda Downing commented it was strange that there is the same rule of body from prior year, and it was her understanding that the ruling body should step down and allow someone else to do it.

VII. **COUNCIL COMMENTS**

President Callahan stated that in the past she has declined being president, but she is excited about this year because of the legislative delegation of the State of Florida and the people she has met in the past and looks forward to it.

Cllr Ciotti stated he looked forward to the progression moving forward. Unsure of how long he will continue to serve, as this year has been taxing, with both President Callahan and he having to look at both operational and assets and still got through it this year. Looking forward to working with new staff and see what happens next year. He further stated it is not unprecedented for small towns, for council

members, based upon the citizens to serve 20, 30 years of their life. He thanked everyone and appreciated it.

Cllr Sindledecker feels that the new members will have an opportunity for next year and is positive about it. She further stated that the training the new members participated in, she wished they had had the training ten months ago and see that that is where we are headed, and this will be a good thing for us and the town. Very positive.
