VIII. <u>ITEMS FOR CONSIDERATION – TOWN MANAGER</u>

1. Request Approval of Agreement By and Between Town of McIntosh and East Central Florida Regional Planning Council (ECFRPC) for Technical Assistance to Support Planning Functions of the Town

Motion by Vice Chair Ciotti to approve the Agreement Seconded by Cllr Sindledecker Motion passed Unanimously.

2. Request to Approve and Schedule Public Hearings for Proposed Referendums on Election Ballot on Tuesday, June 28, 2022, and Tuesday, July 19, 2022, at 7:00 p.m.

Cllr Naworensky commented on the 2nd referendum of whether it should be added to the ballot since the non-resident would not have a vote, and recommended it be removed.

Motion by Cllr Naworensky to strike the 2nd referendum from the ballot Sindledecker; Motion was amended to remove Ref. #1 and 2 from the ballot

Vice Chair Ciotti commented on the need for Referendum #3, carrying the next town meeting to the next meeting.

Motion passed unanimously.

3. Approval of Welcome Guide for the Town of McIntosh (Prepared *by Alison Sorrachi and Karin Harms*)

Vice-Chair Ciotti suggested adding language to page 6 regarding bulk waste must be less than 40 lbs. and on a tarp.

Cllr Sindledecker suggested adding a line stating to contact the Town Hall or reference the Town Website for contact and further information about waste & recycling.

Mayor Roddy suggested adding a reference that the illustrations were done by Karin Harms.

Motion by Cllr Naworensky to accept the guide and pay for the printing. Seconded by Cllr Sindledecker.

Motion passed unanimously.

Cllr Sindledecker commented that the Seedlings Club provides a walking tour guide available at the Town Hall and add an insert to the guide.

IX. <u>COUNCIL COMMENTS</u>

Cllr Jones complimented the events on Arbor Day and the Clinic Open House. She is doing research for the projector & portable screen systems and would like it to be on the upcoming agenda for preparing the budget.

Vice-Chair Ciotti added that Danaya Wright will be present at the Living Trust and Estate Planning on May 26th at 6 p.m. in the Community Center and invited the town.

Cllr Sindledecker added to the importance of preparation and planning for unexpected issues and commented on ways to reach the residents so that she is more informed of the issues/concerns of the residents. Residents are encouraged to call or communicate with their council members so that council members can address those issues.

Mayor Roddy added that he received many comments about having the Arbor Day event on a Saturday and other events on Saturdays for the town.

X. <u>CITIZEN COMMENT</u>

Patty Dodd – commented on disagreements and some positive actions during a council meeting. **Alison Sorrachi** – provided the history of the applicants to serve on boards and committees and commented on the process for choosing applicants for the historical board to be fair.

Beverly Dodder – commented on the process to consider the applicants who wish to serve on the board.

Mary Ann Kelly – suggested using the historical name of the homes for the new McIntosh Welcome Guide, instead of the current owners.

Angie Fogarty – Presented an update to the Arbor Day event. She proposed a Parks and Recreation Committee to host activities and improvements to the parks.
