## I.PRESENTATIONS

### Lyndsey Johannesen- Insurance Account Executive

Provided the renewal and the policy changes.

Fl League of Cities has been the provider for the town for many years.

Rates are going up for the whole state. We were on specified value, there is a specific amount assigned to each property. With inflation, those values are likely going to be underinsured. FLC is no longer using specified, but a blanket plan. We have one large pot to pull from when loss occurs.

On the renewal, the second page had deductible options available.

Specified value plans would only pay out what the building was appraised at years prior. The blanket policy covers the cost of re-build.

Further discussions on the policy and how the policy works.

All asset surveys will be done in the next term. The asset survey is done in person and the report provides premiums for each location.

**Cllr Naworensky**- Asked about general liability insurance and adding as additional insured. Asked if it was required to list tenants as additional insured.

**Lyndsey**- Being named additional insured allows you to have access to the policy. It is recommended not required.

#### Mary Anne Kelly- Civility

Concerned about civility. Defining it needs to be done carefully. Training needs to be done for everyone that represents McIntosh. Due process means you are innocent until proven guilty. Civility starts with the first encounter.

**President Ciotti** notified the residents of strange things happening around town, please be careful and lock the doors.

**Al Richter-** Requested the council consider a Welcome sign at the entrance signs on HWY 320. The fire hydrants need to be painted.

Joyce Terry- Asked about parking on the right of ways.

**June Glass**- Parking on the right-of-way is against the code, Jessi could send a letter to everyone in town or put it on the water bill.

Janice Strange- Asked about the wires that are hanging from old cable companies.

**President Ciotti-** Altitude was previous company that the lines belonged to and there are no resources for them to remove the wires since they are out of business now. We can investigate an estimate from another company to do it.

**Cllr Jones-** Asked what we would do after the third offense.

Cllr Sindledecker suggest \$500-1000

**Mary Ann Kelly**- Request that we have a policy on if someone wants to use the water from the hydrant.

**Karin Harms-** Thanked the council. **June Glass-** Thinks 14K is too much.
