VII. **ITEMS FOR DISCUSSION**

1. Appropriation Update-  
**TM Gonzalez-** The appropriation has passed through the house and the senate side. We received the list for the county-by-county allocations and our project is on the list. The Governor has not finished with his line-by-line vetoes yet.
2. Appointments  
**TM Gonzalez-** We have followed up, but we still do not have any more information. I expressed concern about the upcoming budget.
3. Marion County Day in Ocala  
**TM Gonzalez-** Marion County Day was a fun-filled day. Several flyers were passed out for our upcoming festivals. Our community center rental got a lot of attention.  
**Mayor/President Roddy-** If we want to remain as a municipality, we need to make our name known.  
**VP Ciotti-** The office sign needs to be done. We should consider getting an ad for the community center in a bridal magazine.

**Mayor/President Roddy-** We budgeted \$7k for the community center rental.

**TM Gonzalez-** That is something that we may be able to do depending on where we are in the budget.

**Attn Corbett-** If it is in the budget, it wouldn't need to be approved, but the sign would need a vote, so it will have to wait.

**TM Gonzalez-** We have also discussed setting up a booth at the local bridal expos.

*Further discussion on the community center rentals, garden show & annual yard sale.*

**Mayor/President Roddy-** Asked TM Gonzalez about the bill regarding Form 6.

**TM Gonzalez-** More research is needed. Lobby tools showed the bill amendment was adopted allowing for towns with 500 or fewer residents to be exempt from form 6 requirements. If it did pass, it would not help with this election because it will not start until January of 2025. The last official census was 476.

VIII. **MANAGER COMMENTS**

**TM Gonzalez** provided an update on the comprehensive plan. There is a draft that they are almost done with.

IX. **MAYOR COMMENTS**

The garden show is April 5<sup>th</sup> & 6<sup>th</sup>.

**Mayor Roddy** expressed the importance of keeping our Municipality.

**Lt McQuaig** responded in agreement. He hopes there is some sort of amendment adoption because maintaining the town's status is important. Other towns are struggling due to not having a governing body.

X. **ATTORNEY COMMENTS**

The trial is on April 30<sup>th</sup>. There is no quorum to come to a settlement, so we are preparing for trial.
