**Mayor Roddy-** The upgrades have started, but there are still a few left to do. The Mulch that is being installed is EPA-approved.
2. Tallahassee Trip Recap  
**TM Gonzalez-** This is the first year we had a booth at Marion County Day. We met with our representatives to discuss our building plans and show them the architectural drawings. The meetings went very well. We are fully funded on the Senate side, and it will go to the House next week. There was a discussion on Form 6 with our representatives, and unfortunately, it does not look like there will be any changes any time soon. Some representatives were concerned with what was going on in local governments in Florida, but some felt like transparency was necessary.
3. Appointments  
**TM Gonzalez-** We met with Chelsea Aaron in the governor's office. The applications have been pulled and given to the governor but there is no update on where he is on the matter.  
**Joyce Terry-** Asked who applied for appointment.  
**TM Gonzalez-Chelsea** said that anyone who would like to know who has applied should put in a public records request through their office.
4. Moving Buildings (Yellow & Old Town Hall)  
**Mayor/President Roddy-** The ceiling collapsed in the old office building. We are in discussions with contractors about options to move and/or demolish it. The yellow building may be able to be moved to the warehouse for storage.
