



McIntosh Flea Market Vendor Application

August 8, 2026, 8:00 A.M. – 3:00 P.M.

1. All participants must submit a completed application to the Town Hall located at **20400 10th street or P.O. Box 165 McIntosh, FL 32664**.
2. Individuals, organizations, churches, and schools may apply for a booth. **The application Deadline is July 27, 2026.**
3. **Booths Spaces are \$10 each.** All Payments must be in the form of cash, check or money order made out to Town of McIntosh (Memo for checks "P&R Flea Market").
4. Each participant will be assigned a 12' wide x 10' deep space **in Wayside Park, 20952 9th Street McIntosh, FL 32664.**
5. Participants must provide all equipment (tables, chairs, tents) that they need.
6. Participants may:
 - sell items they own, make, or represent.
 - show photos or distribute information about their services or products.
 - display samples of what they create or sell.
 - make agreements about future products or services, or
 - participate as a fundraiser for their organization.
7. Participants are responsible for care and protection of their assigned area.
8. This is a family-friendly event. All participants are expected to maintain appropriate attire, displays, products, conduct, and overall presentation at all times. Participants must interact in a civil, courteous, and respectful manner with shoppers, fellow participants, and Town representatives.
9. The following are strictly prohibited: vulgar, obscene, or offensive language, images, or displays; nudity or sexually explicit content; drug paraphernalia; and the use, promotion, sale, or display of drugs or drug-related items. The Town reserves the right to require the removal of any prohibited item(s) or display(s) and may remove any participant who fails to comply with these standards.
10. Participants may check in from **4:00 p.m. until 6:00 p.m. on Friday (8/7/2026)** and from **5:00 a.m. until 7:30 a.m. on Saturday (8/8/2026)**. There will be no overnight security.
11. Participant vehicles must be clear of the park by **7:30 A.M. on August 8, 2026, and booths must remain set -up until 3 p.m.**
12. Participants are encouraged to park in the marked area on 10th Street.

NOTE: The park does not contain completely level ground. Participants should plan accordingly and bring any equipment needed to safely and securely set up on uneven surfaces. To be fair to all participants, booth spaces will be assigned randomly. All participants who sell items are responsible for collecting and submitting appropriate taxes.
